The collection of information concerns the request for information, possible subscription to the company newsletter.

Information request

The email and personal data provided during the information request are used solely to facilitate contact between the company and the surfer, i.e. to respond to his/her requests.

3. COOKIES

5. YOUR CHOICES REGARDING COOKIES
